College News

Update to intern funding

HWNZ plans to offer eight internships for 2013/14 - two per regional training hub / DHB region. They will budget for funding for these positions to be accessed from 1 July 2013. The funding will be the same as for other training programmes they support – i.e. by way of a training subsidy from HWNZ. The rest of the funding will come from the employer to make up the total salary package.

We also had a representative at a meeting held earlier this month which included the nine programme directors, a number of heads of departments from the seven universities and Professor Des Gorman, Brenda Wraight and Gregor Coster from Health Workforce NZ. The purpose of this meeting was to inform HWNZ of the range of psychology training programmes. Professor Gorman noted that such a diversity of skills and scopes is a great strength to the profession. A steering group will be formed for further consultation.

Psychologists Prescribing

At the invitation of Health Workforce NZ, the NZCCP Executive has been working on developing a consultation document discussing the introduction of prescribing rights for clinical psychologists. This document is now in the first round of consultation conducted with Health Workforce NZ, the Psychologists Board, the Executive of the Psychological Society and the NZCCP membership. It is envisaged that

the consultative document will be finalised and distributed once again to the membership of each association, other stakeholder groups and the general public for further comment shortly.

Submissions

The College continues to lobby in an effort to persuade MP Steven Joyce to reverse his proposal for cutting government-funded student allowances for postgraduate students. Members of the NZCCP Executive and the Wellington branch have held meetings with MP Grant Robertson on 17 September 2012 and with MPs Grant Robertson and Maryan Street (Labour), Barbara Stewart (NZ First) and with Helen Leahy (Maori Party Chief of Staff) on 18 October who all noted their opposition to the Government's decision to reduce the number of years that student allowance is available.

A collection of personal stories from individual students, including particular issues for Maori and Pacific Island students and communities, will be sent to MP Grant Robertson for sending on to MP Steven Joyce to specifically emphasise how people are adversely affected by this policy. MP Peter Dunne has agreed to a meeting with College members from his constituency to be made soon. It is planned that a coordinated public comment will be made shortly.

great deal of energy and effort to promoting the role of Clinical Psychology in New Zealand.

Jo began training in Clinical Psychology at Victoria University in 1997 after a successful career in communication. In 2003 she completed her Doctor of Philosophy in Psychology and she was registered as a Clinical Psychologist in 2003. At this time she began working in Consultation Liaison Psychiatry at Wellington Hospital, CCDHB. She worked within the medical wards and outpatient settings using and advocating for psychological techniques with clients with a medical illness. She also worked at a community level presenting to groups such as the Cancer Society.

Jo joined NZCCP as a student. She became actively involved in the Wellington branch in February 2002 and was elected as Treasurer in June that year. She held that position for 4 years until 2006 when she took over as Chair of the branch for 2 years. She was awarded Fellowship of the College in 2007.

In addition to volunteer work for NZCCP, Jo was also very involved in other psychology arenas, including heading the contract negotiations committee for the CCDHB clinical psychologists.

Jo was absolutely dependable and not only got the job done, but always put in a large amount of effort to ensure it was done well. She took great pride in her profession and passed on her enthusiasm and knowledge to students and colleagues.

On behalf of NZCCP I would like to acknowledge Jo for all that she has done for clinical psychology in New Zealand and wish Jo and her family peace.

Summary of the Psychology Profession Advisory Forum (PPAF) meeting 29 August 2012

Representatives of the New Zealand Psychologists Board, New Zealand College of Clinical Psychologists, New Zealand Psychological Society, and the university training programmes meet regularly to share information and discuss issues relevant to all aspects of the profession.

Key issues discussed

Cultural Competence – It was noted that the Maori and Psychology Research Unit at the University of Waikato, the University of Auckland Psychology Department, and the National Standing Committee on Bicultural Issues are inviting registrations for the 2012 Indigenous Psychologies: Our Past, Present, and Future conference. The conference will be held on November 16 & 17 2012, at the University of Auckland.

Translation of the Code of Ethics – The project to translate the Code of Ethics into Te Reo is finally completed. The Code and the translation was mailed out to all APC holders and 'paid-up' registrants in late September. A formal launch will be held at the Indigenous Psychologies conference (see item above).

Working with Health Workforce New Zealand (HWNZ) re Internships, Prescription Privileges, and the psychology profession's potential contributions to healthcare in New Zealand - It was noted that a meeting with HWNZ is planned for November 1st. It is expected that representatives from the Heads of Department, the Programme Leaders, the NZPsS, and the NZCCP will attend. The meeting will provide an opportunity to follow up on initial discussions re prescription privileges for psychologists, profession's potential psychology contributions to healthcare, and the funding of internships.

HWNZ have expressed strong interest in the "prescription rights" (RxP) issue. NZCCP have agreed (on behalf of HWNZ) to draft a discussion/consultation document (which will be shared with the other PPAF members as soon as possible). All PPAF members will have the opportunity to comment/contribute to the document after the first draft. In a related development, NZCCP have also of invited members one οf psychopharmacology training programmes in the USA to present at the NZCCP (April) 2013 conference.

It was agreed that a 'task and finish' group will meet soon to refocus on PPAF's shared objectives and how best to achieve them. It was agreed that the profession need to collectively articulate a longer term agenda, but that we can, and should, build on any success with the RxP project.

Reports from PPAF Members

NZCCP: The College reported that -

- They have been lobbying Hon Steven Joyce (Minister for Tertiary Education) in regard to student funding and they will continue to collaborate with student groups on this issue. Their recent press release was picked up by Scoop, and a spokesperson was interviewed by Radio NZ.
- They have just completed a survey re the Board's CCP and audit, with a response from just under 10% of their membership. The results will be shared with the Board once summarised.
- They are helping their Wellington branch offer a "Mental Health Day".
 They are working closely with the Mental Health Foundation, and will be

offering presentations for public consumption. They hope the project will raise the public profile of Clinical Psychologists.

NZPsS: The Society reported that:

- They also have been lobbying re student funding, but have been disappointed with the lack of response from politicians. They particularly noted the contradiction between funding decisions re student allowances and the workforce development role of HWNZ.
- They have now moved to their new, larger premises (Grand Annexe, Boulcott Street).
- Their AGM was recently reconvened at their new premises, and subsequently their new executive is now in place. They also used the opportunity to meet with Institute Chairs.
- A professional development session on the new Crimes Act was recently offered. The new Act redefines the meaning of the family, which could influence other courts.
- A Family Court, bicultural, and other workshops are also being offered.
- They are working on their 2013 conference, which will be held in Auckland.
- The results from their recent survey re professional issues are being collated. The survey included a question about prescription privileges.
- They are continuing to work with the New Zealand Red Cross to develop a psychological first aid programme.
- They are writing a discussion paper on prescribing roles.

HoDs: The HoD representative reported that:

It is very important to remember that internships are, first and foremost, a part of university qualifications. Universities therefore must involved in any related negotiations. They noted for example, in regard to HWNZ's recent announcement that 8 internships will be funded, that a number of questions remain unanswered. How will this funding be done? What impact will it have on current arrangements? How will the funding be spread over the various courses? (In discussion, it was acknowledged that the professional

- bodies are also key stakeholders in the intern funding issue.)
- HWNZ is appointing its Regional Programme Directors of Training for each of the four training hubs. They have appointed Kate Rawlings for the South Island hub, and A/Prof Neville Blampied and other officials from the University of Canterbury are meeting with her on August 30.
- The HoDs will meet again in 2012; hopefully just ahead of any meeting with HWNZ, but certainly before the end of the year.
- A/Prof Blampied's term as an HoD ends this year, so the HoDs will need to appoint a new PPAF representative.
- Some university staff made strong representations re the current restructuring of the Department of Corrections. This seems to have helped to protect key psychology roles. It was agreed that we all need to be vigilant regarding structural attacks on the profession.
- The HoDs are working on a document exploring the development of further pathways to registration. An update will be provided at a future meeting.
- A/Prof Blampied attended the recent 30th International Congress of Psychology (ICP) in South Africa. It was a great conference, and very worth attending. The ICP will next be held in 2016 in Yokohama and in 2020 in Prague. The next International Congress of Applied Psychology will be in Paris in 2014 (and thereafter in Montreal in 2018).

Psychologists Board: The Board reported that:

- Principal Family Court Judge Peter Boshier had recently provided clarity around access to samples of psychologist's work for the court where a competence review was underway.
- A new Steering Group had recently been established by the 16 Regulatory Authorities to develop the terms of reference for a Detailed Business Case (DBC) to further explore the Ministry's proposals for amalgamating secretariats. It was noted that two groups might not participate in the resulting structure. Although most RAs see some possible advantages, the question remains as

- to whether or not those advantages will be sufficient to justify the expense, risk, and disruption caused (hence the need for the DBC). It was also noted that the Psychologists Board remains committed (along with the other 5 "RA Partners") to their 3 core principles and to ensuring that there is meaningful consultation with practitioners before any significant decisions are made.
- Four current Board members' terms expire in September 2012, and the Ministry has recently asked the Board Chairperson to interview two possible (lay member) appointees. The Board's preferred skill set for appointees was outlined.
- The Board have adopted their Māori name (Te Poari Kaimātai Hinengaro o Aotearoa), and the process has gone quite smoothly.
- A working party is reviewing the draft Counselling Psychologist scope core competencies. The Board would like to add more members to this group.
- The 2012 review of the HPCA Act has been launched by the Ministry.
- Good progress is being made on the draft guidelines on the use of psychometrics. There has been a lot of interest from the profession on these draft guidelines. The latest (re)draft has now been posted to the Board's website for further consultation.
- The Psychologists Board meets once a year with their Australian counterparts. This has proven to be a very useful forum. The Australian Board (PsyBA) has just had 4 members replaced, so is going through a period of adjustment. The two boards signed an MoU, which has been posted to the Board's website.
- The Board has been working with the PsyBA regarding the regulation of the profession in the South Pacific island nations. They are exploring what regulations (if any) apply in each jurisdiction and what reach the NZPB and PsyBA have re their practitioners who work in the islands. A guideline for practitioners is now being drafted.
- The Asia-Pacific Psychology Standards network (APPSN) has recently been established. It is hoped that the Network will eventually grow to include all 45 Asia-Pacific nations. The Network's initial goals are

modest, with the first priorities being to establish a contact in each nation and to develop a webpage where people can go to compare and contrast the registration requirements of all 45 countries.

The next PPAF meeting will be held on 6 November (1:00 – 4:30pm).

All present offered their thanks to A/Prof Blampied for his contributions over the past few years, as this was his last meeting with PPAF.

Future meetings

Review: "Mind How You Go"

In celebration of Mental Health Awareness Week the New Zealand College of clinical psychologists (NZCCP) Wellington Branch ran their first ever public event. The event, held at the Wellington Public Library, was titled "Mind How You Go" and involved a number of experienced clinical psychologists providing information in regards to mental health and strategies to enhance wellbeing. The day was structured to briefly cover different periods of the life span.

In the morning, Kim Narsi began the day by giving the near capacity audience a general overview of how a clinical psychologist works with children and families. She used her 12 years of clinical experience to provide information on how to recognize and manage behaviour that is associated with ADHD and Autism Spectrum Disorder.

Following this extremely informative presentation, Dr Karen Salmon explained to the audience what strategies parents and caregivers can use to help raise emotionally competent children. Dr Salmon, an Associate Professor at Victoria University, gave specific examples, such as using descriptive praise and providing clear boundaries, which help children recognize and regulate both positive and negative emotions.

At midday, Gaynor Parkin began a series of presentations on adult mental health. Gaynor, the founding director of Umbrella Health, specialises in psychological resilience to manage stress. She provided research that states that in our daily life we need three positive emotions for every one negative emotion and engaged the audience, asking them to identify as many positive emotions as possible. With over 20 emotions identified, she explained how using techniques such as mediation can help elicit these emotions. Importantly, she emphasized how the development of these techniques can be used to aid resilience during stressful times.

Following on from Gaynor, Dr Erica Chadwick, gave the audience evidence from her PhD research on savouring. Savouring is a set of cognitive-behavioural strategies that individuals can use to respond to positive emotions and events. She explained how savouring is a building block for happiness.

Moving on from positive psychology, Dr Nicole Pray gave the audience an overview of Mood Disorders in Adulthood. Using her clinical experience from working at a recognised trauma centre in the United States, she explained how trauma could result in mood disorders in adulthood. Nicole explained how to recognize symptoms of depression and bipolar disorder and how clinical psychology can help manage and alleviate these disorders.

The day concluded with a presentation by Dr Nick Mooney on busting myths and developing resilience in old age. Nick used a vast amount of research to quash many misconceptions associated with getting old, including as an example the fact that older people are more happy that young adults. He also explained how clinical psychology can help older adults to effectively cope and adapt positively to difficulties associated with growing old in order to maintain quality of life.

"Mind How You Go" was an extremely successful day. The near capacity audience ranged from members of the public to experienced health professionals. We even had an attendee travel down from Whangarei specifically for the event. We received nothing but positive comments from the audience, with many requests to repeat the event. Fuel Aotearoa: Empowering Athletic Girls and Women Through Education

Chronic energy deficiency in female athletes and exercising women is common yet has significant consequences to long term health. That is, low energy availability, whether it develops inadvertently or purposefully and with or without disordered eating behaviours, compromises the reproductive, skeletal and cardiovascular systems and also exercise training and performance. These issues are largely ignored and often not discussed, so Dr Holly Thorpe (University of Waikato) and Maria Bentley (physiotherapist and AUT University PhD candidate) have developed an educational website titled 'Fuel Aotearoa: Empowering Athletic Girls and Women Through Education' (www.fuelaotearoa.co.nz). The website is designed specifically for female athletes, exercising women, coaches, family and health professionals to provide accessible information about the physiological, psychological and social aspects of low energy availability and the Female Athlete Triad. An additional aim is to establish a nationwide network of psychologists who are interested in assessment and management of girls and women who present with or are at-risk for developing low energy availability and the Triad. Pre-Conference workshop with Professor Alan CarrComprehensive Case Formulation for the Assessment and Treatment of Complex Cases
Wednesday 10 April, 9 – 5pm

Assessing and treating complex cases in the fields of child and adult mental health and disability is challenging. Where cases are characterized by multiple risk factors, multiple problems and where there are multiple treatment goals case management can be a difficult process. Comprehensive case formulation and a systematic approach to case management is a very useful way to address such challenges. In this workshop Professor Carr will explain his approach to clinical case formulation and discuss creative ways to address challenges that arise during the planning, assessment, treatment and disengagement phases of the case management process.

Abstracts will appear in the programme exactly as they are provided. Format: double-spaced, in Times New Roman, 11pt, and preferably in Microsoft Word.

- Research papers can be on a clinical, theoretical, or professional area with a time allocation of 30 minutes, including time for questions.
 However, should we receive a large number of quality papers, we may make the time allocation shorter (minimum 20 minutes).
 Empirical papers to include background, aims, methods, results and conclusions. Theoretical or professional topics should include background, aims, main contributions and conclusions. 250 word maximum.
- Practical workshops can be on any professional area with a time allocation of 90 minutes. Abstracts to include background, aims, methods and learning objectives. 500 word maximum.

We encourage you to present using PowerPoint. A technician will be available at the conference and we will provide pc laptops and data projectors or televisions. Please notify the NZCCP office well in advance if you need other equipment. Bring an electronic copy of your reference/presentation material with you so that these can be placed on the website.

All presenters who intend to attend the rest of the conference are required to register for it. At least one author of a poster is required to register for the conference.


